- Facilitate assessment and analysis of the impact of the implementation of response measures, including the use and development of modelling tools and methodologies;
- Provide concrete examples, case studies and practices, in order to enhance the capacity of Parties, in particular developing country Parties.
- Enhance cooperation among Parties, stakeholders, external organizations, experts and institutions,
- Enhance capacity and the understanding of Parties on the impacts of mitigation actions
- Promote action to minimize the adverse impacts and maximize the positive impacts of the implementation of response measures

17. *Encourages* Parties to invest in the early planning of just transition policies that are inclusive and based on stakeholder engagement;

Policy recommendations

- Encouragement to observer organizations or relevant agencies to:
 - Enhance support for addressing issues related to the assessment and analysis of the impacts of the implementation of mitigation actions, policies and programmes, including nationally determined contributions and long-term low-emission development strategies, with a view to addressing the adverse impacts and maximizing opportunities.
 - Enhance and develop their existing training frameworks and modules on assessment and analysis so that they can be used for country-level training programmes and for developing impact assessment tools and methods
 - Engage the private sector, including small and medium-sized enterprises, to facilitate the identification and exchange of experience and best practices to promote the creation of decent work and quality jobs in new industries and businesses.

20. Encourages Parties to:

(a) Consider the availability of country-level expertise, training, support and consultancy services when selecting a tool or methodology for assessing the impacts of the implementation of response measures;

(b) Invest in data collection in line with national and international standards (for example, the United Nations System of National Accounts or the System of Environmental-Economic Accounting);

(c) Establish capacity-building partnerships and networks for increasing the representation of developing countries in the use and development of impact assessment tools and methods for assessing the impacts of the implementation of response measures;

(d) Consider both qualitative and quantitative methods for assessing the impact of the implementation of response measures;


Understanding Just Transition

- Means different things
 - workprogramme are for impacts of response measures
 - Preamble of Paris Agreement in 2015
- One perspective around workers:
 - a framework to encompass a range of social interventions needed to secure workers' rights and livelihoods (Wiki)
 - Transition in a way that is fair and inclusive as possible to everyone concerned, creating decent work opportunities and leaving no one behind (ILO)
 - Implement social protections system/policies for affected workforce
 - Creating opportunity for skills transfer
 - Addressing the issue of energy poverty
 - Social dialogues all voices in decision making process
- Broad perspective:
 - Actions for climate change with inclusive development pathways
 - calls for justice in more general terms, not just for workers (Eisenberg 2019)
 - Manage distributional impacts equally among people, community, workers, consumers, countries, regions, industries (share benefits and supporting who loose economically) (EBRD)
- Energy transition
 - System/technology transformation
 - Regulatory framework
 - Policy frameworks

Transition impact assessment



- If you cannot measure it , you cannot manage it
- Uncertainty
 - in net benefits of green, net zero transition,
 - as well as distribution of costs and benefits among winners and losers.



Sharm El-Sheikh Implementation Plan

To establish a **work programme on just transition** for discussion of pathways to achieving the goals of the Paris Agreement (UAE).

To convene an **annual high-level ministerial round table on just transition**, as part of such work programme, beginning at CMA 5 (UAE).




Others (1)

- Finance-related
 - Financing just transition as topic for Standing Committee on Finance Forum in 2023
 - Mandate to Board of Green Climate Fund to consider how to enhance support for just transitions.

• Mitigation work programme

- Scope to be based on:
 - Broad thematic areas.
 - All sectors covered in 2006 IPCC.
 - Relevant enabling conditions, technologies, just transition and cross-cutting issues.
- Two global dialogue each year and investment focused events with a view to unlocking finance, including for, among others, just transitions.



Others (2)

- Response measures workprogramme related
 - **Call for submissions** for review of <u>functions</u>, <u>work programme and</u> <u>modalities of the forum</u>.
 - Mandate to forum and the KCI to:
 - Facilitate capacity building of countries to develop and use impact assessment methodologies and tools (e.g. through case studies and regional hands-on training workshops).
 - Develop and maintain a web-based user interface for selecting tools and methodologies.
 - Mandate to the UNFCCC secretariat to:
 - Conduct peer-to-peer learning to facilitate planning and implementation of effective policies on just transition and economic diversification.
 - Regularly update the existing database of tools and methodologies.
